Minutes of the Previous Meeting

Chuck Couture made a motion to accept the October 17, 2019 minutes as distributed. Joe Galati seconded the motion and it carried.

Project Review Report

There was one project open for comment.

Executive Director's Report

1. Federal Funding Outlook

The text and accompanying explanatory report were released for the omnibus appropriations acts for FY2020. The House and Senate are in consideration.

The Bill provides \$175 million for ARC; \$5 million more than last year. The report indicates specific dollar amounts for some activities and general support for others. The Bill recommends specific funding levels for the following activities: \$10 million to continue a program of broadband deployment in distressed counties in Central Appalachia; \$5 million

for a program of broadband deployment is distressed counties in North Central and northern Appalachia; \$16 million for a program of industrial site and workforce development in southern and South Central Appalachia, focusing on automotive suppliers and the aviation sectors, with funding allocated according to the area development formula; \$16 million for a program of basic infrastructure improvements in distressed counties in Central Appalachia. The Bill also indicates support for the POWER Initiative and the proposal to address abuse crisis in Appalachia.

2. ARC & EDA Funding 2020

The EDA Planning Grant was awarded in the amount of \$70,000 with a start date of January 1, 2020. The ARC application has been submitted and we expect approval in February 2020 with a retroactive start date of January 1, 2020.

3. ARC Power Application

STW is working on a new project with Allegany County in the amount of \$500,000 to replace antennas with LTE, which goes through foliage much better.

4. Past ARC Projects

Allegany County continues to work with ARC to utilize funds for the Crossroads Water Line Project.

Staff is compiling reports on past projects that will be made available to the Board. This will be a valuable exercise to increase knowledge of past projects and lessons learned as we advise projects in the next cycle starting in February.

5. Angel Fund

October 9, 2020 deadline is set for this fund. Currently there are twelve commitments and twelve checks provided.

6. Availability of Funds

STEDO \$18,000; STEDO Agri Business \$450,000; STEDO Working Capital \$135,000; WRC Downtown Loan \$1,200,000; WRC Working Capital \$8,000; and CCBDC Micro - \$0. *Loans made in the past month total \$460,000.
