Minutes of the Previous Meeting

Correspondence

Secretary Jay Gould read the following correspondence:

1. Letter from Sarah Decker, Deputy Clerk of the Allegany County Board of Legislators, of reappointments of members to the Southern Tier West Board as follows: Kier Dirlam, Jerry Scott, and Craig Clark with term of office commencing June 1, 2016, and expiring May 31, 2019. Reappointment of Curtis Crandall, Guy James, and Lee Gridley as ex-officio members with term of office commencing June 1, 2016, and expiring May 31, 2019.

Project Review Report

Jerry Scott moved to acknowledge receipt of the Project Review Report, Joe Galati seconded the motion and it carried.

Executive Director's Report

1. Federal Update

House republicans introduced a stopgap funding measure that would combine a full year's worth of funding for the rest of the government through January 19th. The current CR expires December 22nd. The proposal that was met with immediate opposition from congressional democrats who object to any strategy that would fund the military before Congress agrees to overall spending levels that also address non-defense priorities. The Senate is working on it sown stopgap proposal, although the duration is not finalized.

Craig Clark reported that ARC training-based programs are not as popular in getting funding - it is more the community-based projects.

2. LUCA – Local Update of Census Addresses

The deadline for responding was December 15, 2017. STW will work with the municipalities that signed up when they receive their information.

3. SARA Grant

Staff will put together a State Archives Grant request. Information has been solicited from the towns and villages across the region who are interested. A motion was needed to approve submitting the grant to NYS Archives on January 16, 2018. Kier Dirlam so moved, Jerry Scott seconded the motion and it carried.

Southern Tier West Program Report

Executive Director Richard Zink reported on the following STW programs: Local Government, Broadband, Entrepreneurial Development: Youth Entrepreneurial Academy and Angel Fund, NYSERDA – Clean Energy Communities, Geographic Information Systems, SARA Records Management, and STEDO.

Committee Reports

1. STERA

Richard Zink reported that STERA met on December 6, 2017. STERA is awaiting the City of Jamestown to complete their feasibility study for the rail excursion proposal, which is approximately a six-month process.

Public Comment

Craig Clark reported that an EDA grant package was submitted and approved for the Biorefinery and that NYS agreed to put in the remaining dollars, so the project can begin to move forward.

Kier Dirlam reported that the paving project and new parking area at the Crossroads facility has been completed.

Old Business

There was no old business.

Chuck Couture made a motion to approve the October Audit Abstract. Donna Vickman seconded the motion and it carried.
